ORDINANCE NO. 975

**AN ORDINANCE OF THE CITY OF BENTON CITY,
WASHINGTON, AMENDING THE 2017 BUDGET, AS ADOPTED
BY ORDINANCE 966.**

WHEREAS, the City Council of the City of Benton City, Washington, adopted the 2017 budget in final form by Ordinance No. 966 on the 13th day of December, 2016;

WHEREAS, subsequent thereto it has become necessary for the City to amend said ordinance because of revenues and expenditures of the same, which could not reasonably have been foreseen at the time of adopting said budget; and

WHEREAS, the 2017 budget revisions are unexpended appropriation balances of a preceding budget carried forward from the prior fiscal year and transfers between individual appropriations all pursuant to RCW 35A.33.120.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BENTON CITY, WASHINGTON, AS FOLLOWS:

SECTION I. The following accounts contained in the 2017 Budget are hereby amended as set forth below:

SECTION III. This ordinance shall become effective five days after its passage by the Council, approval, and publication.


