**AMENDMENT #7  
INTERLOCAL AGREEMENT  
BETWEEN CITY OF WEST RICHLAND  
AND CITY OF BENTON CITY  
FOR STREET SWEEPING SERVICES**

THIS AMENDMENT IS ENTERED into by and between the CITY OF WEST RICHLAND, a municipal corporation of Benton County, Washington, hereinafter referred to as "West Richland" and CITY OF BENTON CITY, a municipal corporation of Benton County, Washington, hereinafter referred to as "BENTON CITY", for street sweeping services, and is effective January 1, 2019 upon execution by both parties.

## **Attachment B**

### **Street Sweeping Services**


2019 hourly rate, including labor, equipment, and administrative fee, shall be \$180.30/hr.  
(hourly rate to be charged from West Richland's shop to West Richland's shop)


Rate to be amended annually on January 1st
